- 1. The agent should take agency by depositing Rs.5000/- (non refundable) as processing fee. The agent has to renew every year before the due date by paying Rs.250/- only, failing which the decision of the management / company shall be final. This amount may vary from time to time. Please contact office for further details.
- 2. The agent should buy at least one solar light kit of his choice either home light system or compound light system @ the corresponding listed price.
- 3. The agent will enjoy flat commission @8% (eight percent only) on MRP of the product he / she successfully promotes. The other charges like taxes etc are always extra.
- 4. The agent should never accept any money from the customer or get involved in the monetary transactions with the customer for the products we deal with or the customer is interested. He / she should only help the customers to make a payment into our bank accounts.
- 5. For any such transaction between customer and agent, the management / company does not hold any liability. The agent owes full responsibility of such misdeeds not concerned with the company.
- 6. The agent should arrange payment by the customer into the bank account specified by the company only and in no case he / she should physically get in touch with cash and the same transaction should not be from any of his third party members, friends or relatives and if done so can be deemed unfit for any sale / commission / transaction.

If the agent makes any institutional supplies and bulk sales they will be provided with an over riding commission @ 3% only on volume basis after materialization of the relevant payment.

- 9. In case more than one agent is appointed in the same area the total commission any, if payable by the company, will be taken into pool account and will be distributed as per individual performance.
